

**Sub: Limited Enquiry**

The Dzongkhag Administration, Bumthang is pleased to invite eligible restaurant/hoteliars license holder to participate for operation of Archery Canteen at Wangdicholing for the period of one year form the date of award of work. The terms and reference for leasing of operation of Archery ground canteen are as follows:

1. The Evaluation of the bid shall be based on bidder who quote highest monthly rental with the minimum of Nu. 7000 (seven thousand only) per month and above and shall carry a weightage of 60% for the purpose of the evaluation.
2. The bidder must compulsorily quote item rate as per the list attached for all the menu to be applicable and it shall carry a weightage of 40% for the purpose of the evaluation.
3. The sealed quotation should reached the office of the undersigned on or before 11:00 AM and will be opened at the same day at 12:00 PM
4. The winning bidder shall be required to submit a lumpsum amount of Nu.30,000 (twenty thousand only) as a security deposit addressed to The President, Bumthang Sport Association (BSA) in the form of cash warrant, demand draft or unconditional bank guarantee issued by a financial institution located in Bhutan, which shall be furnished before signing of the contract agreement. The performance security deposit shall be valid for one year.
5. The service provider shall deposit the monthly rent on or before fifth day of every month as a rental charges to the treasurer, BSA, Bumthang. Failing to which the penalty of 0.01% each day of delay to a maximum of 10% of the rent in a week shall be applied. If the service provider fails to pay the rent for three consecutive months the performance security of Nu.30, 000(thirty thousand only) shall be forfeited and terminate the contract accordingly.
6. The parking lot for the archery players must be imposed at his own rate depending upon his strategy.
7. The entry fees for archery players must be imposed at his own rate depending upon his strategy.
8. The archery ground must be maintain well with clean surrounding.
9. All the utility bills pertaining to electricity,, water and telephone charges shall be borne by the canteen proprietor only.
10. The committee will monitor as and when complain arises on operation of canteen and archery ground pertaining to hygiene, quality and maintenance of archery ground.
11. Sale of items beyond the quoted rates will be strictly prohibited.

12. The operator shall take care of all the litters emerging from the canteen. All such litters should be segregated and disposed properly.
13. The committee shall not take responsibility for the settlement of credit dispute between customers and the operator.
14. The operator shall pay all the applicable takes as per the business law of kingdom during the tenure of the operation.
15. The tenure of the contract shall be for the period of twelve months effective from the date of signing of the contract agreement subject to provision for the renewal.
16. The operator shall provide sufficient furniture and space for customers required in the canteen.
17. The operator shall be responsible to provide "Baa" during the match and practise.
18. The item rate for the canteen should be displayed at the payment counter for ready reference.
19. Alteration or change with any type of existing facility is prohibited unless the management decides to do so.
20. The committee reserves the right to terminate the parties, if the above terms and condition is not fulfilled and security deposit shall be forfeited.
21. The decision of the committee shall be final and binding.
