**Notification**

**Revised Waste Offences and Fine Schedule**

In exercise of the powers granted under section 53 of the Waste Prevention and Management Act of Bhutan 2009 and section 171 of the Waste Prevention and Management Regulation 2012, the 55<sup>th</sup> session of the National Environment Commission meeting held on 18 August 2022 deliberated on the proposed revision and subsequently endorsed the *Revised Waste Offences and Fine Schedule along with Incentives and Reward Strategy* on 10<sup>th</sup> November, 2022, and further Cabinet approval was accorded on November 30, 2022. The revised waste offences and fine schedule shall supersede the offences and fine schedule under Annexure VII of the Waste Prevention & Regulation 2012 and offences under section 56 of the Waste Prevention and Management (Amendment) Regulation 2016.

*The Revised Penalty and Fine Schedule for waste-related Offenses including the incentive and reward strategy will come into effect from the 15<sup>th</sup> of December 2022.*


